

## **PROHIBITED ITEMS (CONTINUED):**

ALL MEDICATIONS REQUIRE: Patient's name, name of medication, provider's name, and expiration date (if applicable).

Over the Counter (OTC) Medication MUST be in the **original container**.

\*\*PRESCRIPTION MEDICATIONS or OTC pills **cannot be mixed**, they will be seized if comingled. \*\*

### **VAPE JUICE**

Limited to 3 bottles of 3.5 oz. or less.

MUST HAVE original factory seal.

### **OTHER PROHIBITED ITEMS**

Alcohol, any organic products, insects, human / animal body parts, plants, flowers, seeds/leaves, throwing knives/blades, brass knuckles, knives with blades designed to be concealed, butterfly knives, spring loaded knives, classified documents, live ammunition, explosives, flares, grenades (even toy), Galaxy Note 7 phone, aerosol cans, currency > \$10K, Cuban cigars, historic/foreign artifacts, pornographic material, embargoed or unauthorized trademark goods in multiples.

# U.S. CUSTOMS

## WHAT WE DO:

Eliminate the introduction of agricultural pests, various diseases and the flow of illegal drugs and contraband from the USCENTCOM AOR into the United States through DoD and DoD contracted transportation.

## WHAT WE LOOK FOR:

- Agricultural hazards which may pose risk or danger to U.S. soil and agriculture.
- **Contraband , Illegal substances, ammunition, pornography, alcohol, prohibited/restricted items IAW CENTCOM R600-10 and CENTCOM GO-1C**

## PROHIBITED ITEMS

The following are items to be aware of when returning to CONUS from the CENTCOM AOR for customs inspection purposes. The list is not all inclusive, but are frequently confiscated upon departure.

### **\*\*LIGHTERS\*\* (NEW)**

No BIC style, disposable, or torch lighters.

No butane, gas, or liquid lighter fluid, or torch lighters permitted.

Zippo shells ARE permitted, as long as the insert containing fluid is removed.

Up to 4 books of matches are allowed.

### **FOOD AND POWDERS**

Fresh fruits/vegetables, and unlabeled products **ARE PROHIBITED.**

**\*\*Consumable powders MUST be in their original factory labeled container.** This INCLUDES nutritional supplements such as vitamins, dietary supplements and protein powder**\*\* Organic powders are prohibited.**

### **MEDICATION**

**Prescriptions MUST be in the original pharmacy labeled and issued container.**
