

Dependent Return to Bahrain from Authorized departure/safe haven status.

I **DO NOT** have pets. How do I get my dependents back to Bahrain unescorted?

1. Go to the NAVCENT homepage. (<https://www.cusnc.navy.mil/>)
2. Click on the “Click here for family and pet return checklist.”
3. Download the Application for Transportation of Dependents (DD-884)
4. Download the Passenger Reservation Request (NPPSC-4650.1)
5. Fill out and send the forms to: “m-ba-cusnc-n1-addistro@us.navy.mil”

I **DO NOT** have pets. I am approved to escort my dependents back. (ex: single parent, MIL/MIL). How do we return to Bahrain?
