1. This correspondence is provided as a supplement to the information in Block 10, "Circumstances of Loss or Damage," of the DD Form 1842 submitted by the members assigned to U.S. Naval Support Activity (NSA), Bahrain. It serves to verify the conditions under which the claimed personal property loss occurred.

2. On or about 28 February 2026, multiple facilities aboard NSA, Bahrain sustained damage and/or structural compromise as a result of hostile military actions. A complete list of affected facilities is provided in enclosure (1).

3. If claimant's personal property was in one of the impacted buildings, this structural compromise may have directly caused the loss of or damage to the claimant's personal effects. This property loss was an event beyond the member's control and occurred as a direct consequence of their assignment to NSA, Bahrain.

4. This letter certifies damage to the structure itself and does not verify that the claimant's property was in the structure at the time of the incident. Each individual command is responsible for certifying the claims of their assigned personnel.

5. Property that was left behind is not a payable claim until you have proof of destruction, it has been returned to you in damaged form, or you are notified via official channels (e.g., a Command directive) that your items will not be retrieved. Please ensure a copy of the proof of damage/destruction or the official notification is included with your claim when submitting it to the Personnel Claims Unit Norfolk.

6. This Supplemental Statement is part of a larger package that must be submitted to Office of the Judge Advocate General, Personnel Claims Unit Norfolk (OJAG Code 15) for adjudication in
